Compilation of draft text of the international legally binding instrument on plastic pollution, including in the marine environment*

Note by the secretariat

1. At its fourth' session, the intergoverningutal negotiating committee to develop an international legally binding instrument on plassic pollution, including in the marine environment, stabilished reo contact groups (contact groups), and 2) to consider, respectively, the elements addressed in Parts 1 and 10 of the reysted data text', including any relevant proposal anness (contact group) 1) and the elements addressed in Parts III, to VI of the revised draft text, including any relevant proposal annesses, (contact group 2). The Committee also devided that the work of the contact groups would be further divided among subgroups (subgroups 11, 12 and 1.3 for contact group 1), and subgroups 2.1 and 2.2 for contact group 2).

2. Following completion of the work of the contact groups and their respective subgroups at the fourth session, the committer respectived the secretaria to issue a complication of the five outcome documents of the bibgroups, maintaining corresponding placeholders for potential annexes as contained in decument, UNEPPINDC.473, as an official document for its fifth session. 3. The compilation contained in the annex to the present not was prepared by the sccretariat pursuant to the mandate described above.
